Personal Data Protection Law No.6698 ("PDPL") grants data subjects of personal data, defined as relevant person, (hereinafter to be referred to as "**Applicant**"), the right to make certain requests regarding processing of their personal data in article 11 of PDPL, and under the first paragraph of article 13 of PDPL, applications to be made with regard to such rights must be submitted to us in writing or through other methods determined by the Personal Data Protection Board (the "Board").

In this regard, "written" applications to be made by the data subjects of personal data in person and and/or through their authorized representative may be submitted to us by printing out this form and using the application methods defined below.

- Application in person by the Applicant
- Through a Notary Public
- By sending of the application to the e-mail address given in this form by the Applicant
